


Watch and Protect

The Missing Link in Damage Prevention





According to the 2022 Damage Information Reporting Tool (DIRT) Report, despite increasing efforts in conventional approaches to damage prevention, the overall damage per thousand (DPT), has continued to rise (9.34% since 2020). During that same period, TRC's Watch and Protect Program has helped our client's DPT decrease by 20%.

Natural gas and telecommunication facilities accounted for the majority of damaged assets in 2022. Are your employees, contractors and third-party excavation contractors adhering to applicable regulations for excavating around buried facilities?

THE TRC WATCH AND PROTECT PROGRAM ENHANCES EXISTING DAMAGE PREVENTION PROGRAMS.

The Common Ground Alliance (CGA) recommends outreach and stakeholder communication; enhanced training for professional educators on damage prevention; and addressing root causes of damage such as failure to notify one call center, failure to pothole and maintain clearance and accurate mapping.

TRC's Watch and Protect Program helps enhance your damage prevention program by creating a culture of teamwork and collaboration between third-party excavators, the locating entity and TRC's pipeline safety team. Establishing this Safety Culture has proven successful in protecting assets and reducing safety incidents.

Our Watch and Protect employees are trained and qualified to identify safe and unsafe excavation practices around your facilities to protect the assets and the personnel working near them.

Over a three-year period that TRC implemented a Watch and Protect program for a major pipeline operator, our client experienced a 20% reduction in overall DPT tickets. Additionally, contractor negligence dropped from the leading root cause of damage to the third cause. Since implementing TRC's suggested audits on untoneables, our client has seen a 60% reduction in reports received. These trends highlight the collaboration of TRC's Watch and Protect team with local contractors and reducing risk of asset damage for our clients.
